

Promotion Terms and Conditions

General

1. Information on how to enter and prizes forms part of these Terms and Conditions of entry. Entry into the Promotion constitutes acceptance of these Terms and Conditions.
2. The Promoter is **V/Line Corporation ABN 91 273 289 190** of Level 9 750 Collins St, Docklands VIC 3008.
3. The Terms and Conditions of this Promotion are governed by the laws of the State of Victoria.

This Promotion is a game of chance. Skill plays no part in determining the winner. The winning entrant will be drawn at random with each entrant having equal chance of being drawn.

Who can enter?

4. Entry into the Promotion is only open to Victorian residents who are, at the time of the Promotion, aged 18 years and older and residing in Victoria.
